SUBJECT: Approval of Baseball Infield Improvement/Maintenance Bid

DATE: March 29, 2021

Included in the approved FY2021/22 Fund 65 budget is \$50,000 for baseball field improvements/ maintenance. After detailed inspections and meetings with Glencoe Youth Baseball, it was determined the most impactful course of action was to complete maintenance on Berlin Baseball Field's infield. To meet the performance/appearance standards previously discussed by the Board of Park Commissioners (B+) in February, the field requires sod replacement, clay grading, and home plate/mound maintenance. This work is a result of heavy use and weather conditions.

Based on the timing of required maintenance, this was not a project that was able to be completed with in-house labor. Therefore, the project was taken out to bid. Three qualified bids were received and opened at the March 25, 2021 bid opening for Baseball Infield Improvement.

Glencoe Youth Baseball has agreed to a \$10,000 (30%) cost-share on the project. Per the bid document, we are awarding the project to the lowest qualified bidder. Based on the nature of the work, the field will be closed for a short period of time this spring (April/May 2021).

Therefore, the lowest qualified bid is from Advanced Turf Solutions of Fishes, Indiana, for a total base bid of \$29,575. Advanced Turf Solutions provided excellent references.

At the April 1, 2021 bid opening for the North Beach Access-Stairway Project, four bids were received and opened. The initial budget estimate for the construction phase of this project is \$265,000.

The bids were favorable with the base bid below the project budget.

Per the bid document, we are awarding the project to the lowest qualified bidder.

Therefore, the lowest qualified bid is from Martam Construction of Elgin, Illinois, for a total base bid of \$175,404. Martam Construction provided excellent references with experience in roadway construction, bridge building, and retaining wall repairs.

Martam previously completed the repairs to the Schuman Overlook.
