Dear District Residents:

Glencoe Park District seeks your thoughts and recommendations on a possible bond referendum that may appear on the November 2024 ballot.

The District seeks to protect and improve some of Glencoe's most important and iconic public assets, without increasing its current debt service tax rate.

A summary of the proposed improvements is provided below, each of which will be further vetted through a community input process this spring and summer:

- Glencoe Beach Sun Shelters and Boardwalk. Updating aging sun shelters, replacing the boardwalk, and adding a permanent cover to the trellis.
- Glencoe Beach Playground. Adding shade, and updating the aging spray features and playground equipment.
- Safran Beach House. Making interior improvements, which have not been addressed in almost 30 years. Adding restrooms and showers that provide easier exterior access.
- Glencoe Beach Access. Rebuilding and reinforcing retaining ramps and walls, as well as parts of the staircase leading to the beach, that have not yet been updated. Materials would reflect the historic appearance of the walls and staircase.
- Perlman Boating Beach. Updating the boat house building's siding, restrooms, and deck, which were last renovated in 2005. Improving and expanding storage spaces for kayaks and paddleboards.
- Takiff Center's North Field. Replacing the aging backstop and updating the athletic field's 45-year-old electric infrastructure. Potentially adding indoor batting cages as part of the proposed improvements to the parks facility
- **Greenhouse.** Constructing a new greenhouse, for community groups and individuals to use, potentially at Shelton Park to replace the old greenhouse behind the Takiff Center.
- Parks Maintenance Facility. Building a new parks facility that would include electric vehicle (EV) charging stations and solar panels; space to properly store materials, equipment, and vehicles, including future EV vehicles and equipment; and provide work and office space for maintenance staff. The existing parks facility and storage spaces, which are 39 to 94 years old, are in poor condition and lack efficiency.

The Glencoe Park District works hard to maintain our parks and facilities using existing funds, including grants and donations. However, certain large-scale capital improvements tied to aging and failing infrastructure fall outside of what our budget can address.
